GENERAL USE DIRECTIONS: To spray, hold container upright. Point valve opening away from yourself and press button firmly.

Flies, Gnats, Mosquitoes and Moths Treatment: Most effective when sprayed directly on flying insects. Spray in a sweeping motion. Contact as many insects as possible. Repeat as needed.

Note: When used indoors, wipe away excess product.

Food Areas of Food Handling Establishments: Foods should be removed or covered during treatment. Wash or wipe away excess product.

PRECAUTIONARY STATEMENTS: While not required with EcoSMART's organic plant oils, we recommend good safety practices when using any insecticide, such as avoiding contact with eyes and skin. If product gets in eyes, flush with water. If on skin, wash with soap and water. If irritation persists, contact a physician.

PHYSICAL HAZARDS: Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause container to burst.
